
Subject: Rotation of officers posted on Sensitive Posts-regarding

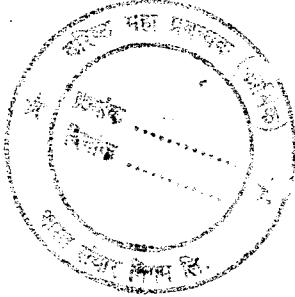
